Potter Township Tax Collector

Residents receive a combined County and Township tax, as well as the Per Capita Tax bill around March 1 st of each year. The School tax bill is received around July 1st of each year. The tax rate for the School District and the County are set by the governing bodies of those two entities. The Board of Supervisors establishes the tax rate only for the Township.

Per Capita tax bills are sent to all adult residents of the Township regardless of if you own or rent your property. The total payment is \$10.00, which goes to the Township only.

A few items to make note of when paying your taxes:

- To pay your taxes, either mail the payment or come to the Tax Collector's Office during the hours printed on your bill. There is also a drop box outside the Tax Collector Office door that you can leave your payment in.
- · Cash will be accepted but check or money order payments are preferred. No credit card payments are accepted.
- When paying multiple tax bills, you can pay all bills with one check.
- Please review your payment before mailing to verify the correct amount, and date and signature are included.
- Please include a self addressed stamped envelope for a receipt.
- Please notify the tax collector of any address change as quickly as possible. Tax bills are not forwarded. Non-receipt of a tax bill does not excuse the taxpayer from payment responsibility.
- Looking forward to the end of the year, please remember that tax bills not paid in full by December 31st become
 delinquent and subject to additional penalties.
- Personal checks for the payment of real estate taxes and per capita taxes will not be accepted after December 15th for the payment of real estate taxes due in that calendar year. Payments must be made by certified or cashier's check, money order, or cash from December 15th to December 31st.

TAX OFFICE - SPRING HOURS

Office hours for the March 1st collection will be April 21-30 (discount period ends April 30), Tuesdays and Thursdays from 3:00 to 5:30pm, & Wednesdays from 9:00am to Noon

The tax office is closed on weekends and holidays.

Potter Township Sewage Management Program

New residents of Potter Township should be aware all properties located in Potter Township that are served by an on-lot sewage disposal system are subject to Potter Township Ordinance Chapter 156. Part 2, Article V. The Ordinance requires all on-lot sewage disposals systems located in Potter Township be inspected and pumped every six (6) years. Notices for the properties subject to that Ordinance this year will receive notice after April 1st of this year. Inspections of the systems must be completed on or before August 31st and those systems required to be pumped must be pumped on or before October 31st. Copies of the pumping receipts must be submitted to Potter Township.

If you receive notice that your property is subject to inspection and pumping this year and you are ready for your inspection prior to being contacted, you may contact our Sewage Enforcement Officer, Stan Wallace at 814-571-7231 to schedule an inspection.

The new Potters Mills Central Sewage Treatment

The new Potters Mills Central Sewage treatment is up and operating following years of water testing, studies, regulatory submittals and engineering. The first discharge of effluent to Sinking Creek occurred in mid November. Most dwellings and business have been connected to the system and the remainder will be connected in the near future. With the exception of a few minor control panel issues the start up has gone smoothly and the treatment plant is preforming as designed. As often occurs

with a project of the complexity involved with this system and one involving multiple connections of private home and businesses, each with their own set of unique characteristics, there were a few minor delays and problems, but with the excellent support of the engineers, contractors and equipment manufacturer we have almost reached the total completion of the system.

The cooperation of Village residents during the entire process was commendable. Future generations will greatly benefit from the environmental improvement to the community.

The contractor will be returning in the spring to complete pumping of old tanks and restoring yards. After weather improves, the Board of Supervisors

Sinkholes and Water Quality

If you live in a rural area, you probably get your water from a well or spring. For health and aesthetic reasons, you want the groundwater that supplies your home or farm to be of high quality. But groundwater can become contaminated as a result of human activities, including the misuse of sinkholes -- depressions in the land surface that occur in areas underlain by carbonate bedrock, such as limestone and dolomite. Carbonate bedrock exists in many parts of central and southeastern Pennsylvania.

An important characteristic of carbonate bedrock is that it is easily dissolved by water. Some water from rain or melting snow seeps through the soil to recharge the groundwater contained in bedrock fractures and openings between rock layers. As the water flows through these cracks, the carbonate bedrock gradually dissolves and the openings become large, creating solution channels through which water can easily flow. The dissolution of carbonate bedrock accounts for the development of sinkholes; as the bedrock beneath the soil is dissolved and carried away, the overlying soil settles or collapses to form a surface depression. These depressions vary in size and are usually cone or bowl shaped.

The soil lining the bottom of a sinkhole may be so thin that it provides little filtering of any surface runoff that may drain into the sinkhole. In some instances, streams may flow into sinkholes and disappear underground. This surface water now becomes part of the groundwater flow system. Because sinkholes provide easy access for drainage water to enter the groundwater system, it's important to keep potential water pollutants away from sinkholes. Contaminated water that drains through a sinkhole can pollute the groundwater that you (or your neighbor's) well or spring draws from. Since groundwater can flow easily through solution channels in carbonate bedrock, a sinkhole that receives contaminated water can pollute water supplies located far away from the contamination source.

- If you have a sinkhole located on your property, you can do several things that will help protect groundwater quality
- Most important, don't use sinkholes as dumping sites. Sinkholes may seem like acceptable locations to dump trash, but they're not. The water from precipitation and drainage that flows through trash-filled sinkholes carries contaminants directly into groundwater.
- Never dump rinse water from sprayer tanks or any other hazardous liquids into sinkholes. These liquids will reach groundwater easily.
- Avoid using sinkholes as outlets for drainage tiles. This water may contain contaminants --such as pesticides and nitrate
 -- that have leached from the soil.

You can take several positive actions to prevent sinkholes from becoming entrance ways for groundwater contamination:

If you have a sinkhole that contains trash, you should clean it out. This will help curb any further groundwater contamination and may discourage additional dumping.

Keep sinkholes and the area immediately around them vegetated with trees, shrubs and grasses. This buffer of vegetation will help stabilize the area, filter contaminated runoff and provide wildlife habitat. Undisturbed sinkholes that don't receive contaminated runoff aren't a threat to groundwater quality.

Sinkholes are environmentally sensitive areas that need to be treated with care. Remember: What you see in a sinkhole may affect what you get from your water faucet.

National Safe Digging Month - April 2020

Pennsylvania One Call System, Inc. is celebrating 48 years of continuous service to the Commonwealth. Partnering with Pennsylvania One Call are governmental agencies whose efforts are to promote safe digging within their communities. The Potter Township Board of Supervisors support the "National Safe Digging Month" campaign in the State of Pennsylvania and wish to promote this grassroots campaign by recognizing the month of April 2020 as "Pennsylvania 811 Safe Digging Month".

Frequently Asked Questions (FAQ's)

Do I have to call if I am digging on my own property?

Yes, you are required to inform the utilities of any type of work involving the movement of earth with powered equipment.

· Who should make the call?

The person who is doing the digging should place the one call notification. If you are a homeowner and you've hired an excavator to do the work, the excavator is required by law to call to have lines located (refer to Section 5 of PA Act 287).



If you are digging with powered equipment the person operating the equipment must call. It does not matter how deep you are digging or where you are digging within the Commonwealth of Pennsylvania.

Is a one call required when doing paving?

Yes, since powered equipment is being used and the earth is being disturbed, the utilities need to be aware so valve boxes and manholes are not paved over.

What are PA One Call's hours of operations?

The call center is open 24-hours a day, 7 days a week, every day of the year.

How many days do I have to wait before I can begin digging?

State law requires a three (3) business day notice (does not include state holidays or weekends), but not more than ten (10) business days prior to the start of excavation. A business day begins at 12:00:00 a.m. and ends at 11:59:59 p.m. The first lawful start date for your excavation is determined by your scheduled excavation date (the day you plan to start digging), work should not begin prior to your first lawful start date but no later than 10 business days from the day of your call.

· Can the lawful start dates change?

Yes, the first date of the lawful start date is determined by the scheduled excavation date and should be not less than 3 business days from the date of your call. However, if more than three (3) business days notice is given prior to the start of excavation, the first lawful start date will be the date given as your scheduled excavation date.

· What can be done if I know someone is digging and they did not contact PA One Call?

According to **Section 7.2 of PA Act 287 as amended,** local law enforcement or emergency management personnel may, in the interest of public safety, order excavators on a site to stop further excavation, if the excavation is being conducted in violation of this act. This may also be enforced under **Section 3302 of PA Title 18** Section b - Risking catastrophe.

If you observe excavation work and have reason to believe that a one call notification was not placed, you may contact PA One Call to place a No One Call notification. PA One Call will search its records for the worksite you describe to determine if a valid One Call notification was placed. If none is found we will notify the utilities in the area of the excavation work.

Additionally, any alleged violation of the Law should be reported to the PA Public Utilities Commission by completing an Alleged Violation Report in the Enforcement section.



Take Me out to the Ball Game

In September 2019, the Potter Township Board of Supervisors voted to purchase the baseball fields located at 150 Summer Lane, Centre Hall. Formerly known as the "Shaner Fields", the complex is comprised of 29 acres and includes 2 baseball fields, a concession stand and press box. The baseball fields were previously owned and operated by State College Baseball Club, Inc.

The facility has been named Potter Athletic Complex, or as we fondly refer to it as "the PAC", and is home to two regulation size baseball diamonds, a concession stand, press box and restroom facilities. For many years the fields have been home to Spring Mills Braves, State College Legion Baseball, and State College Wild, just to name a few. The Complex will continue to be home to various baseball leagues, as well as local and regional baseball tournament s for both youth and adults.

The fields themselves have been given new name. These names were selected for their historical value as a part of Potter Township's story.

EMERY FIELD (the lower field, with the overhead lights) was named after Cal Emery who was born in Potter Township (Centre Hall) in 1937. He won the Most Outstanding Player award for the College World Series in 1957. He was a first baseman for the Philadelphia Phillies in 1963. After playing MLB, Cal took on

a position as batting coach for the Chicago White Sox in 1988.

GEISS FIELD David and Catherine Geiss sold forty perches of land (near Tusseysink) to the Potter Township School District on January 25, 1867 for \$25. The one-room frame building was erected the same year and was used continuously until 1956 when Potter Township closed its last seven schools. (from "Potter Township: General Potter's Empire", by Ruth Rishel (1976)

Supervisor Jake Tanis and the Parks and Recreation Board have been working together on repairs to facilities, landscaping and updating the concession stand and press boxes. All hands are on deck to be ready for baseball season. The facilities also include one lighted baseball diamond with dugouts, one baseball diamond with dugouts (no overhead lighting), press boxes, concession stand, storage buildings, parking lot, bleachers, picnic tables, and scoreboards.

Teams have already lined up for the season and fields have been assigned. Aschedule for practices, games and tournaments can be found on our website at www.pottertownship.org.



From the Zoning Office



Logging:

Are you planning to cut and remove timber from your property? If so, please be aware a permit is required from Potter Township before hauling any timber from the property. Certain Potter Township roads have a posted weight limit, and if your logger plans to use one of the roads with a posted weight limit a bond must be established with Potter Township prior to hauling any timber from the property. Please contact Stan Wallace, Zoning Officer at 814-364-2456 prior to removing any timber.

Construction:

Most new construction, additions, installation and some remodeling and repairs will require at the minimum a Potter Township Zoning Permit and others may require a Potter Township Zoning Permit and a Uniform Construction Code Permit. Please contact Stan Wallace, Zoning Officer at 814-364-2456 prior to construction with any questions you may have. The Zoning Office will be closed from June 22nd through July 6th.

Celebrate Kindness on 1-4-3 Day



Branch and Limb Collection - May 11 & 12, 2020

Residents must call the Township Office prior to 12 NOON on Thursday, May 7th to schedule their pickup.

Please Note: This is a one-time only spring collection.

Collection Guidelines

- Brush must be piled with the ends of limbs laying in the same direction, preferably pointing toward the road.
- · Mixed or tangled piles will not be picked up.
- · Maximum diameter of limbs is 6 inches.
- · Do not tie brush in bundles.

- Crews will spend no more than 15 minutes at one property.
- Equipment limitations require that brush must be separated from leaves and other debris. Leaf collection is not an available service.

Stumps, old firewood, garden plants, ornamental grasses, and construction material will not be picked up.

Riff Raff Collection - May 15 & 16, 2020

Potter Township will hold its fall Riff-Raff Days on Friday, May 15, 2020 from 7 a.m. to 3 p.m. & Saturday, May 16, 2020 from 7 a.m. to 12 noon. Items will be accepted at the township maintenance building only on these dates.

NEW GUIDELINES AND LIMITS

ONLY the following items will be accepted:

- Metal items
- Appliances
- · Large furniture
- · Electronics: Computers, TV's, printers
- Tires-(limited to 6) must be removed from rims. Tires from your property only.

* This collection is **NOT** for residents outside of Potter Township.

The Township will provide riff raff collection for senior citizens 65 or older & physically disabled residents on **Thursday**, **May 14th.** Requests for this special collection require pre-registration. To register, contact the township office no later than 5 p.m. on *MONDAY*, *May 11th* by calling (814) 364-9176, ext. 100. Remember to place all items at the edge of your property next to road by 7:00 a.m. on collection day. Keep in mind that there are only 2 workers per collection vehicle during this special collection. Items that cannot safely be lifted by 2 workers WILL NOT BE COLLECTED.

The Township appreciates your cooperation in adhering to these guidelines as this will allow the continuation of this free service to the residents of Potter Township in the future.

Electronics Recycling



f your electronic items are not included in the list above, you can throw them in your regular trash

Act 108 of 2010 (The Covered Device Recycling Act), bans all covered devices from landfills, however, the Centre County Recycling & Refuse Authority offers a free drop off service for residents. Covered Devices includes desktop computers, monitors, laptops, computer peripherals and televisions.

Electronics Drop Off Hours: Mon-Sat; 8am-4pm.

All electronics drop off items must go to the Scale House.

DROP OFF TIP

Electronic Drop Off Hours: Mon-Sat; 8am-4pm. When coming to our facility to drop off electronics, go through Gate 1 and follow the signs to the SCALES for drop off instructions.



Drop Box Available

Residents who wish to drop off their utility payments or permit applications after hours are welcome to use the drop box. The box is located next to the front entrance of the Administration Office.

Tri-Municipal Park

Lot of things going on at Penns Prairie at the Tri-Municipal Park! If you haven't driven by across from Sammis Greenhouse on Lower Brush Valley Road lately you will be surprised! Things are starting to really come into shape.

We have the two full-size, multi-purpose fields almost ready for play. We should be seeing the fields available for soccer and football starting in the fall after the grass has had a chance to grow stronger. We have a nine hole disc golf course that is challenging and has already seen tournament action. Drive back on the center road and to the course and start to play. Many thanks to Gavek Signs for the sign showing the course layout and to Leo Sammis for the neighborly support that he has given the park! The second nine holes are scheduled to be completed this summer. For those not familiar with disc golf, think of a golf course except that instead of hitting a ball into a hole you throw a disc/Frisbee into a basket.



We are in the planning stages for a 5K race to be held at the park in late April that will be held to support a girls softball team that trains out of Spring Mills. We are hoping that this will turn into an annual event that will include the opportunity for all participants to plant a tree associated with Arbor Day.

Speaking of trees, we have a major tree planting planned for late April or early May to enhance the overall appeal of the park and to provide shade where needed. We will be planting over 100 trees of various types and sizes at this time. This is being funded largely by a Tree Vitalization grant from the DCNR but will require a good bit of community involvement to complete. Volunteers are urgently needed to help plant trees (no experience necessary). The plan is to recreate the prairie that was here when the first settlers arrived in the area. What the original settlers found here is best described as an Oak Savannah with open fields and occasional trees that were predominantly oak trees. We will be in need of 30 – 40 volunteers to get the trees planted, mulched, staked and watered, so please if you can volunteer for a Saturday in early May please let us know by email at 1tmpinc@gmail.com or call Karl Eysenbach at 814-364-9423. We will also be in need of some mechanized support as well in the form of backhoes and or augers to dig holes and bucket vehicles (tractors or skid steers) to move trees, mulch, and water around the site. This is a worthwhile project for a worthy cause. It is also something that counts as a charitable donation with the IRS since the park is a registered 501(c)3 organization. We are grateful to the Penns Valley's Outdoor Club at the high school and the Chesapeake Bay Foundation for their participation in this project, as well as additional tree and shrub planting that they are planning for the park.

Other things on the near-term horizon include a picnic pavilion that will be available for groups and special events. So, come out and see the park, the disc golf course, the new playing fields and volunteer to help us develop the park.

Days Gone By

According to Emmanuel United Church of Christ church records the church was at various times called Earley or Loop Church. The land for the church was deeded in trust to Mr. Conrad Dillman and Mr. Christopher Henney by Barbara and William Earley, Esq. in 1797. The church sits on the edge of the village of Tusseyville, earlier known as Churchville. In 1878 Churchville apparently appealed to the United States Postal Service to establish a post office. The Post Office Department did not allow a name to be used by more than one office in each state, and there was already a Churchville Post Office in Bucks County. The village changed its name to Tusseyville. The United States Postal Service has shared the following information about the Tusseyville Post Office:

Heatstroke prevention and car safety

The dog days of summer are upon us, which reminds us that heatstroke prevention is more important than ever.

On average, 38 children die in hot cars across the United States each year. Together we can prevent these tragedies from happening. In recognition of Heatstroke Awareness Day on July 31, below are tips from the National Highway Traffic Safety Administration.

- Look before you lock. Get into the routine of always checking the back seat of your vehicle before you lock it and walk away.
- A gentle reminder. Keep a stuffed animal or other memento in your child's car seat when it's empty, and move it to the front seat as a visual reminder when your child is in the back seat. Or place your phone, briefcase or purse in the back seat when traveling with your child.
- A routine check. If someone else is driving your child, or your daily routine has been altered, always check to make sure your child has arrived safely.
- A key to safety. Keep your vehicle locked and keep your keys out of reach; nearly three in 10 heatstroke deaths happen when an unattended child gains access to a vehicle.
- Act fast to save a life. If you see a child alone in a vehicle, call 911. Chances
 are the child was left by accident. If the child appears in distress or is nonresponsive, remove the child from the vehicle and spray the child with cool water.

Fireworks Safety Tips

- Obey all local laws regarding the use of fireworks.
- Know your fireworks; read the cautionary labels and performance descriptions before igniting.
- A responsible adult SHOULD supervise all firework activities. Never give fireworks to children.
- Alcohol and fireworks do not mix. Save your alcohol for after the show.
- Wear safety glasses when shooting fireworks.
- Light one firework at a time and then guickly move away.
- Use fireworks OUTDOORS in a clear area; away from buildings and vehicles.

- Never relight a "dud" firework. Wait 20 minutes and then soak it in a bucket of water.
- Always have a bucket of water and charged water hose nearby.
- Never carry fireworks in your POCKET or shoot them into METAL or GLASS containers.
- Do not experiment with homemade fireworks.
- Dispose of spent fireworks by wetting them down and place in a metal trash can away from any building or combustible materials until the next day.

Key Milestones for the 2020 Census

- September 2018 —The Census Bureau's recruitment Web site went live: 2020census.gov/jobs. For each decennial census, the Census Bureau begins recruiting thousands of paid census takers to help ensure a complete and accurate count. Interested applicants can visit the Web site to apply for a variety of jobs beginning in 2019 and through summer 2020.
- April 2019 —The 2020 Census Web site goes live: 2020census.gov. This site will be available in multiple languages and will provide downloadable materials, answers to frequently asked questions, and more information about how individuals and organizations can help spread the word about the 2020 Census.
- August 2019 —New Statistics in Schools classroom activities are available on-line: census.gov/schools. The Statistics in Schools program provides resources for teaching and learning with real-life data.
- January 2020 —The first enumeration of the 2020 Census takes place in Toksook Bay, Alaska. Local census takers must get a head start while the frozen ground allows easier access to remote areas with unique accessibility challenges.
- March 2020 The public can begin responding to the 2020 Census on-line at 2020census.gov. Replying by mail or phone will also be an option.
- April 2020 Every 10 years, we observe Census Day on April 1.
- June 2020 through July 2020 Census takers go door to door to count people who have not responded to the 2020 Census. Census takers are Census Bureau employees and will provide proof that they are official government personnel.
- **December 31, 2020** —By this date, as required by law, the Census Bureau reports to the President of the United States the population count and the apportionment of seats in the U.S. House of Representatives to each state.
- 2021 —Initial 2020 Census data are made available to the public on census.gov.

2020 Census at a Glance

The census is much more than just a head count. It provides a picture of our nation that helps determine where to build new schools, hospitals, and businesses; how federal funding is distributed; and how congressional seats are apportioned. It also helps us see how our communities have changed over time. That's why an accurate count is so important.

UNDERSTANDING THE CENSUS

Once every decade, the federal government conducts a census of the entire population to count everyone in the United States and record basic information about them. Our nation's founders believed this data was so important that they mandated the decennial census in the Constitution.

EASY AND CONVENIENT

In 2020, for the first time ever, the U.S. Census Bureau will accept responses on-line, but you can still respond by phone or mail if you prefer.

CONFIDENTIAL AND SECURE

Strict federal law protects your census responses. It is against the law for any Census Bureau employee to disclose or publish any census information that identifies an individual or business. Census Bureau employees take a lifelong pledge of confidentiality to handle data responsibly and keep respondents' information private. The penalty for wrongful disclosure is a fine of up to \$250,000 or imprisonment for up to 5 years, or both. No law enforcement agency (not the DHS, ICE, FBI, or CIA) can access or use your personal information at any time. Data collected can only be used for statistical purposes that help inform important decisions, including how much federal funding your community receives.

The Census Bureau has a robust cybersecurity program that incorporates industry best practices and federal security standards for encrypting data.

The safety of event participants, attendees, staff, volunteers, sponsors and spectators is a top priority. The decision to cancel is consistent with this priority to prevent the potential exposure and spread of illness.

Playground equipment is not sanitized routinely, so please use at your own risk. During your park visits, please practice social distancing and good hygiene as recommended by the CDC.

The Township will remain in close communication with local, state and federal partners and take further action as needed, based on the recommendations of these agencies. Residents are encouraged to follow the Centers for Disease Control (CDC)'s prevention strategies.
